TRANSPORTATION PROGRAM FUNDING**

**RESOLUTION 2023-84**

**WHEREAS**, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

**WHEREAS**, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

**WHEREAS**, the Tribe desires to enter into a contract with the Bureau of Indian Affairs to administer the Tribal Transportation Program funding, which provides notification of 2% Transportation Planning/Design and Construction Funds available for immediate award and obligation; and

**WHEREAS**, the Tribal Transportation Program funds will be utilized for resurfacing and expanding the parking lot at The Delaware Tribe of Indians tribal offices located at 601 High Street, Caney, Kansas.

**NOW, THEREFORE, BE IT RESOLVED**, The Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve to enter into a contract with the Bureau of Indian Affairs to administer the Tribal Transportation Program, the maximum funding amount of \$93,202.95, in association with and according to the approved scope of work, budget and budget justification.
