**WHEREAS**, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

**WHEREAS**, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

**WHEREAS**, all appropriations of the Delaware tribal funds made by this resolution are for three (3) years appropriation starting October 1, 2023 and ending September 30, 2026, covering fiscal years 2024, 2025, and 2026 and subject to the fiscal year limitations set forth in this resolution, unless otherwise stated; and

**WHEREAS**, the funding agency approved the proposed budget awarding the Delaware Tribe of Indians Family and Children Services Domestic Violence Program 1,000,000.00


**WHEREAS**, Family and Children Services has budgeted the new amount in the attached Budget; and



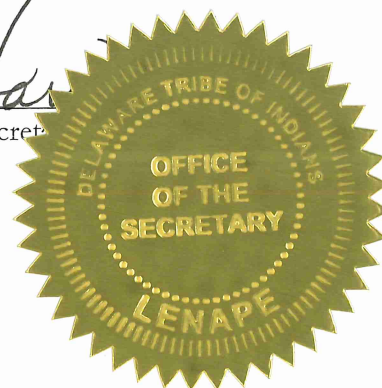
