CHANGES TO THE FAMILY AND DOMESTIC
RELATIONS CODE, ARTICLE 4, SECTION 177 CHILD
SUPPORT TO BRING CODE INTO OFFICE OF CHILD
SUPPORT SERVICES COMPLIANCE.**

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

WHEREAS, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

WHEREAS, Family and Children Services Child Support Program is required for compliance with the Office of Child Support Services Code of Federal Regulations per stipulations in the awarded Child Support grant funding; and

WHEREAS, the Delaware Family and Domestic Relations Code is out of compliance in regard to the Office of Child Support Services Federal Regulations. Changes need to be made to Article 4. Article 4, section 177 on page 43 of the Delaware Family and Domestic Relations Code. The following section is out of compliance.

4-177. Payments.

Child support payments shall be made to the Delaware Tribe of Indians CSS, except as otherwise provided. When payments are made to the Delaware Tribe of Indians CSS, DCSS shall distribute the payment to the appropriate agency or individual; the required change removes "except as otherwise provided"; and will be replaced with the section below.

4-177. Payments.

Child support payments shall be made to the Delaware Tribe of Indians CSS. When payments are made to the Delaware Tribe of Indians CSS, DCSS shall distribute the payment to the appropriate agency or individual.


WHEREAS, the Delaware Tribal Council of the Delaware Tribe of Indians adopts this resolution; to express the desire of the Tribe to approve the required changes to Article 4. Child Support of the Family and Domestic Relations Code on page 43 to bring the code into compliance per the stipulations of the Office of Child Support Services grant funding requirements.

NOW, THEREFORE, BE IT RESOLVED, The Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve the changes required in the Delaware Family and Domestic Relations Code.
